



Course Choices and Pathways

Carefully selecting your course offerings is the foundation of developing a strong CTE department.

Steps to Selecting Courses and Pathways

- 1. Identify student interests or area needs.
- 2. Identify courses within current offerings that lead to "nowhere".
- 3. Consider staff strengths and interests.
 - a. Do NOT allow this to drive your choices!
- 4. Identify courses that can serve multiple pathways or needs.
- 5. Ensure you build in opportunities for students to earn their computer science credit.
- 6. Once pathways are set, avoid change unless it fits the above criteria.

Do students have a choice? Students have a choice...but once a choice is made...they stick with it!

Student Choice

- 1. Early Communication
 - a. Rising Freshmen Curriculum Night
 - b. Freshmen Registration (Counseling)
 - c. Course Offerings at Middle Schools
- 2. Students Who "Don't Know"
 - a. Enroll in a course that fits multiple pathways OR enroll in needed computer science. Sometimes, this can be both.
- 3. Once Students Start a Pathway
 - a. When there is a choice, allow them to choose.
 - b. Leaving/Switching is not a choice...UNLESS you have enough electives and a plan to complete the new pathway.
- 4. Teachers and students discuss options and make decisions together.

Student Recruitment

Identify the right students for the right reasons...

Offensive/Early Recruitment

- 1. Establish increasing CTE completers as a priority.
- 2. Clear Communication
- 3. Informing Stakeholders Early
- 4. Freshman Registration Making Informed Decisions
- 5. Transparency Regarding Process
 - a. Ensuring students know and understand their choice and that following through on that choice is an expectation.
- 6. Communicating Potential Value In Completion (Certifications, Internships, Etc.)

Maintenance and Growth

- 1. Communicating pathways early in the course
- 2. Identifying strengths and weaknesses of students- possible pathway change
- 3. Identify ways for students to see value (partnership with athletics)
- 4. Value of earning a certification
- 5. Recognition at graduation for being a completer Completer Cords
- 6. Post high school opportunities



Teacher Recommendations

- 1. Creating relationships with students to better understand their needs
- 2. Individual meetings with each student to discuss next course
- 3. Documentation will streamline the recommendation process (See form below)
- 4. The process is repeated on block schedule, be mindful of scheduling timeline in the spring





Counselor involvement is essential to ensuring students are enrolled in the correct courses.

Counselor Involvement

- 1. Ensure counseling knows and understands the goal of increasing completers.
- 2. Students need to hear it from admin, teachers, and counselors.
- 3. Add a completer "check" into your IGP process.
 - a. Consider utilizing a checklist.
- 4. Provide information to students and parents for reference during the course registration process.
 - a. QR Code on registration card.
- 5. Your counseling director NEEDS to be on board!

THEFE LEDUCATION Impact on CCR/Incentive/Certifications There is no easier way to qualify a student as CCR than through required coursework.

Utilizing Completers to Increase CCR

- 1. Ensuring students follow their pathway, as mentioned, will qualify them as a completer. Adding a certification along that pathway qualifies them as CCR.
- 2. Find a certification that fits the pathway. Utilize the certification list.
- 3. Early Release and Parking Form
 - a. We do not approve Seniors to take an abbreviated schedule (or park on campus) without being CCR.
 - b. 90% of the time a student has had two courses within a pathway.
 - c. They submit the early release form indicating they will take the additional course.
- 4. Remember, a student is only CCR if they have the certification with the coursework.
- 5. This is an excellent way to capture your special populations through their required 7 elective credits.
